

Fort Sage Board of Trustees Regular Meeting November 16, 2022

Unapproved Minutes

CALL TO ORDER: The meeting was called to order by President Ryan Von Ins at 5:30 p.m.

ESTABLISHMENT OF

A QUOROM: Pam Auld, Erinn Reed, and Ryan Von Ins were present.

MEMBERS ABSENT: Constance Jenkins.

PLEDGE OF ALLEGIANCE: President Von Ins led those present.

ADDITIONS/DELETIONS/

APPROVAL OF AGENDA: MSCU (Reed/Auld) to approve agenda as presented.

COMMUNICATIONS:

Herlong High School: Superintendent Tomes speaks about WASC and explains what WASC is and their purpose.

The school has an upcoming WASC review in April and the school has to submit a report showing evidence of improvement in areas of deficit from the last review. Roy Casey introduces himself and explains why the district has hired him as a consultant to assist Dr. Tomes in areas of improvement for the district. Dr. Tomes explains the process of how Roy

Casey and him work together and that they meet 3 days a month on site.

Fort Sage Middle School/

Sierra Primary School: Superintendent Tomes speaks in regards to the letter from Patty Gunderson in regards to the

Williams Review and steps the school needs to take for improvement. Dr. Tomes has asked teachers to take an inventory of curriculum in their classrooms so that curriculum can be

ordered.

Mt. Lassen Charter: Hillary Magarrell speaks in reference to the report she submitted this afternoon and her

enrollment numbers. She states there is currently a waiting list for students to attend MLCS and that she intends to admit those students. Hillary offers to provide coverage for staff at the high school and primary school if she has staff available. MLCS will be having CAASPP

Testing between Thanksgiving and Christmas breaks. Hillary speaks about tiered

interventions for students and meeting student's specific needs. MLCS is currently using a vendor for PLC's. MLCS is in a mid-cycle review with WASC and has a review due on

November 20th, 2022.

Adult Education/CTE: Ms. Dieter reported that classes are Monday, Tuesday and Wednesday nights and there as

been a great turn out. FFA went to national Convention along with 78,000 students from across the country. Currently the Parli Pro Team is working towards competition, pigs are

going well, students are making wreaths and continuing community service.

WASC: Superintendent Tomes states he addressed in his previous comments and the review is in

April.

CFT: Nothing to report.

Superintendent Tomes speaks about the grant that was awarded to us. CIA spent a few days on campus at the highs school, primary school and charter school to address safety. She feels her grades failed during distance learning and not having a teacher to help her. She speaks on school clubs and how members work hard and the positive impact clubs have on students. Esmeralda feels kids won't do their work at home on distance learning.

Anne speaks via Zoom about distance learning and she feels students fail on Edgenuity and don't take it seriously. She noticed as a primary teacher that third graders read below grade level.

Nicole Halmos speaks about how doubling up on classes doesn't work. She asks the community for help and expresses the difficulty in finding teachers to come work in the district.

Lisa Alexander speaks about the positive changes Dr. Tomes has made. She is afraid of the impact on students with distance learning and requests community members come together and help.

Hillary Magarrell speaks and asks people to remain open minded and that Edgenuity is does not mean sending kids home to learn.

Becky Hulsey speaks and says part home and part school model worked good for her students. She states students are not learning at school with 60 kids shoved in a gym when teachers don't show up.
