CORRESPONDENCE: Superintendent Bryan Young speaks about CSI plans and the areas in which the district

qualifies. The district will be applying again as we have been awarded \$414,000 in past years. The district will be filing for an extension on the Safety Grant so that the way the funds are spent is specific to our district needs. Letter received from WASC regarding Mt. Lassen Charter and accreditation being reaffirmed. Erinn Reed is resigning from the board of trustees effective February 16, 2023. Superintendent Young wants the board to be aware of the extra work load on Heather Von Ins has in regards to the business-related duties of Mt. Lassen Charter. Hillary Magarrell states she gets calls daily requesting enrollment of students and see a continuing need to serve the children. Hillary states she understands the burden on the

business end and wants to support the district with that. Ryan Von Ins asks Hillary if she has considered hiring Administrative Support. Hillary states she has and is also looking into becoming an independent charter school.

BOARD MEMBER REPORTS:

Erinn Reed speaks about how great basketball at the high school has been. Ryan Von Ins talks about a recent training the board members attended. He also states there are four Promethean Boards set up and ready for class use at the primary school and the high school will be set up tomorrow.

SUPERINTENDENT'S REPORT:

Superintendent Bryan Young states that community volunteers have been running the high school basketball games and doing a great job. He gives an update on the support the district has been receiving from the Lassen County Office of Education. MAPS testing has been completed for the spring and test scores are low but the district is working on improvement. There was a recent hire of Nicole Halmos by the county office of education for the After School Program. The After School Program will be getting a storage outside of the classroom for supplies. Teachers will be having training on Promethean Boards on 2/28/23. The district is working on making up lost instructional minutes and will have a plan on how to do that soon.
