Herlong High School/Title I Sierra Primary School Mt. Lassen Charter:

Superintendent Bonn discussed school closure strategies. Chromebooks and Hot Spots

have enabled the District to better serve students from home.

Adult Education/CTE Kim Dieter reported: The FFA Parli-Pro team competitions have been postponed, but

they continue to be competitive placing in the top 6 at state level.

WASC Kim Dieter said that the WASC committee review team recommended the District

change action plans, which is being worked on and can continue via Google Classroom.

WASC visits have been cancelled due to COVID-19.

CA Federation of Teachers: President Kim Dieter said that negotiations will have to be postponed due to school closures.

Classified School Employees

Association: Superintendent Bonn noted that MOUs are being worked on to address school closures, putting

negotiations for next school year on hold.

BOARD MEMBER REPORTS: Mike Everett said that he would continue doing the important work of serving on the

Board if he had more time to devote to it. President Jobbins reported that he has been retired for exactly a month now but the paperwork for his retirement has taken up most of

his time. He looks forward to having more time to spend focusing on his Board role.

SUPERINTENDENT'S

REPORT: Superintendent Bonn reported that information is constantly being released regarding

> COVID-19 and school closures. He provided an update of current information. The major decisions that will need to be made will be at home instruction methods and providing meals to students while school is closed. School is likely to be closed for the remainder of the school year so things will continue to change between now and then. Unions have made a very positive contribution for employees. Graduation requirements and testing waivers are forthcoming. A graduation ceremony will happen but the timing is not known yet. Every contracted employee will be compensated during the school closure and there will be no need to use sick or vacation leaves. Employees will be paid their daily rate in addition to their regular hourly rate for working on-site during the closure, with authorization. The current closure is in effect until April 14, 2020. Site Council and

Board Meetings can be held remotely for social distancing.
