Extra-Curricular/Co-

Curricular Eligibility Policy: A discussion was held concerning conditions to participate in activities contained

within the policy, specifically pertaining to acceptable grades. Superintendent Bonn stated that his main concern was students failing classes but participating in sports and not making academics a priority. Ms. Dieter requested that revisions be made to remove D, S, and Incomplete grades as disqualifications. Erinn Reed also said that she would like Incomplete and D grades removed. She said that she would like teacher input on the policy. Superintendent Bonn mentioned that the policy has been available in Google Classroom for teacher input but only a few teachers have participated in the discussion. Nikki Johnson spoke about being concerned for academics but also accommodating the needs of students. Mr. Otis said that he has worked with several students to improve their grades, but students need to be reasonable and comply with deadlines in order for this to happen. Superintendent Bonn recommended that the Board table the item until the July regular meeting so that revisions can be made. The item was then tabled to the July regular meeting.

Elementary School Teacher: MSCU (Gebbeken/Reed) to approve the hiring of Mr. Clark.

MOU Between the Fort Sage Federation of Teachers and the Fort Sage Unified School District Regarding Credit for Out-of-District Experience:

Superintendent Bonn explained that in order to protect, recruit and retain our

teachers it is important to change our practices to align with other districts. The MOU makes it possible to credit incoming teachers with up to 11 years of prior service as opposed to the current 5. Most districts offer 10. After a brief discussion, MSCU (Reed/Jobbins) to approve. Superintendent Bonn also stated that the MOU would need to have a Public Disclosure completed and submitted to the County

Office of Education before it would take effect.
