

Fort Sage Board of Trustees Regular Meeting January 20, 2021 Approved Minutes

CALL TO ORDER: The meeting was called to order by President Pam Auld at 5:35 p.m.

ESTABLISHMENT OF

A QUOROM: Pam Auld, Erinn Reed, Constance Jenkins and Ryan Von Ins were present.

MEMBERS ABSENT: Tim Jobbins.

PLEDGE OF ALLEGIANCE: President Auld led those present.

ADDITIONS/DELETIONS AND

APPROVAL OF AGENDA: MSCU (Reed/Von Ins) to approve agenda as presented.

COMMUNICATIONS:

Herlong High/Sierra Primary: Superintendent Tomes spoke about recent challenges with student behavior and fighting at the

High School. The goal is to work with students and families not to suspend but to constructively correct behavior. He said he is proud of the community and parents for how positively they have received feedback. Today Central CA Intelligence, who did a site safety assessment of Herlong High about 18 months ago, was again on site for further review. This visit will include an assessment of Sierra Primary as well, which will assist in determining how safety grant monies will be spent. Last Friday was a distance learning day at Sierra Primary due to an unforeseeable staffing shortage. The transition from in-person to distance

learning continues to be worked on.

Mt. Lassen Charter Director Hillary Magarrell reported that the online intervention program spoken about in last

month's update is now in place. An inventory system is being established for curriculum and other resources to be better utilized. Excess curriculum will be shared with other schools in the District which will benefit everyone. The storage facility that has been rented in past

months will no longer be necessary.

FFA: Ms. Dieter reported that students are busy with team practices for virtual contests that are

taking place in multiple categories including Parli-Pro and Public Speaking. Activities in

preparation for the annual Plant Sale, to begin May 1, will soon be underway.

CA School Employee's

Association: President Jesse Hodson reported that Dennis Chaffee has started as Custodian at Herlong

High. Chapter contract negotiations remain in progress.

Superintendent's Report: Superintendent Tomes: Today was the CSI (Comprehensive School Improvement) grant

deadline and it was submitted with the possibility of receiving \$340,000 in funds to decrease suspensions, improve performance in ELA and Math, and increase student engagement. Behavior intervention strategies are being reviewed, including the suggestion of assembling

various groups to address issues at Herlong High and prevent destructive behavior. Plans are underway to provide Middle School students grades 7-8 a dynamic education experience, including separation from High School students as much as possible and the establishment of the Middle School's own identity. At the High School, Michelle Beckett and Superintendent Tomes have switched offices if you can't find them in their usual spots. Distance learning is replacing waivers for occurrences such as snow days. Whenever possible the State will expect us to go to distance learning as opposed to closing the school. We will need to prepare ourselves for this. Feedback is being sought from staff to perfect the process as much as possible.
