ACTION ITEM: MOVE THE 2020-21 FIRST DAY OF SCHOOL TO AUGUST 31, 2020:

A discussion was held regarding delaying this year's school start date to accommodate pandemic preparedness. Interim Superintendent Tomes conveyed that he believed starting on August 31, 2020 would be the wisest choice for the District in order to have a really good start to the year for students and staff. County Superintendent of Schools Patty Gunderson also supports the delay. Michelle Beckett said there is leeway built into the current board approved calendar to adjust and have 180 instructional days without going past the original last day of school, and that it will be modified and brought back to the board for approval at the August 19, regular meeting. Herlong High School is still searching for a Custodian, who will have a very important role in students returning to the campus. Conditions and the well-being of students and staff, and liability for the district, are primary concerns. Erinn Reed brought up concern that students want to return to school and be able to socialize with their peers. Michelle replied that while that is very important, and our kids are missed, we need to be 100% sure that we have a good plan moving forward, and that everything that can be done will be done to ensure a great year for students. Dr. Tomes invited the Board to visit the campus for a preview before school starts to see how things will be organized. The Re-Entry

plan has been worked on and reviewed by the bargaining units and will be on the
