The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Parents, teachers and school staff were invited to review, discuss, and add to the plan at all stages of its development. As the 20-21 school year unfolded, we began to see that there was a significant gap in learning due to the shut-down during the 19-20 school year. Parents and community members began asking what the school district was going to do to address the gap. When staff began discussing what strategies we would employ address the issue, staff (teachers and paraprofessionals) agreed to providing an extended school year and Saturday School instruction to begin to address the need. Instructional Aides will be providing support during extended school year. All staff were extensively involved in this development. This plan was discussed at a community meeting held where we discussed the need to provide additional resources for our students as we addressed the learning gap we detected.

A description of how students will be identified and the needs of students will be assessed.

All students and student groups, including low-income, foster youth, homeless, students with disabilities, and students who are below grade level, will be invited to participate in the extended learning program for extended school year. High School students at risk of not graduating, and those having received a letter grade of D or F on quarterly grade reports, will be strongly recommended to attend Saturday School. Needs will be assessed by reviewing each student's work and learning level during the current school year to create an individualized plan of action for each participating student. The district utilizes Northwest Evaluation Association (NWEA) MAP Testing, to measure student proficiency and growth, and is investigating additional tools for assessment. This will allow the district to measure the effectiveness of evidence-based practices by student in order to identify needs and formulate interventions that will help close achievement gaps.

COVID-19 has limited our ability to conduct the important face-to face meetings we normally would have had to discuss concerns with student academic success. We have begun using Aeries communications, letters home, fliers, automated phone messages and word of mouth to notify parents/guardians of supplemental learning opportunities.

A description of the LEA's plan to provide supplemental instruction and support.

Saturday School will be offered beginning April 17, 2021 through the end of school (June 17, 2021). Saturday school is offered to those 7-12 students who have received D's or F's in their report cards. It is also for any student who wishes to receive extra credit or has a special project they are working on with a teacher. Extended school year will be offered beginning July 6, 2021 through August 6, 2021 Monday-Thursday for a total of 19 days at 5 hours per day. Two elementary school teachers, plus two instructional aides or as needed will provide support for the Extended School Year program at Sierra Primary on a pre-arranged schedule. Details for the Herlong High/Fort Sage Middle School ESY have not been confirmed yet, but is estimated to run the same dates as Sierra Primary with the same staffing numbers. Teachers will work Saturdays on a pre-arranged schedule for Saturday School at Herlong High/Fort Sage Middle. Instructional Aides may work extended hours during the school year as needed to provide continued instructional support. Meals and transportation will be provided each day classes are held during the extended year. Assessments of student learning, growth and achievement will be ongoing. School safety improvements will be made to campuses in order to promote a positive school climate, and support student's academic and social-emotional needs.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Fort Sage Unified School District is coordinating the use of the Expanded Learning Grant and other federal ESSER funds by budgeting all funding sources across several categories to best meet the needs of the local district, staff, students and community. In 2021-22, the Expanded Learning Grant funds are primarily budgeted towards credit recovery services to accelerate progress towards closing the

achievement gap, diagnostic assessments and progress monitoring; and paraprofessional staffing. In 2021-22, the ESSER funds are primarily budgeted toward school facility repair and improvements to reduce the risk of virus transmission and support student's physical, mental, and emotional health needs. In 2022-23, the ESSER funds are planned to be budgeted towards personal protective equipment, sanitation supplies, and any additional student supports that are needed to promote continued health and well-being and positive school climate, including additional staffing costs if needed.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
